Florida East Coast Baptist Association Board of Directors Meeting 08 February 2021, 07:00 pm

NOTE: The minutes reflect a synopsis of the meeting. The entire meeting is recorded and a copy may be requested.

Invocation was given by Deacon Raymond Smith.

After the invocation, an Inspirational Word was given by Pastor Nathanuel Ward. Pastor Ward's text was taken from Jeremiah 29.11, and Acts 1.8. He spoke from the topic: "Christ Centered." The points of his timely, powerful message were: promise, power, presence, and two purposes.

Rev. Dr. Jimmie L. Bryant called the FECBA Board Meeting to order at 7:13 pm. Chairman Bryant called for the Reading of the Agenda and Adoption. President Howard Barr moved to adopt the agenda. President Benjamin Parrott seconded the motion. The motion passed unanimously.

Chairman Bryant called for Mrs. Valerie Brant Wilson, FECBA Parliamentarian, to read selections from Roberts' Rules of Order according to the Bylaws. Parliamentarian Wilson also included tips on how to handle motions using Roberts' Rules of Order as a guide.

Chairman Bryant called for phone numbers that did not have a name displayed on the zoom call to be identified. Rev. Demetric Ford identified Dr. Venita Timpson and Sis. Daisy Fulton.

Chairman Bryant called for the reading of the 2020 Joint Session Board of Directors Meeting Minutes by Rev. Wendell H. Paris, Jr. Rev. Paris indicated that the board meeting's minutes were emailed to the board. Chairman Bryant asked if any board members did not receive a copy of the board minutes. All had. Chairman Bryant gave the board time to peruse the minutes. Dr. Venita Timpson raised a point of concern: In consideration of timing, Dr. Timpson suggests that all minutes be sent to the board at least a day in advance, to allow the board ample time to peruse, edit and

correct the minutes. The motion to receive the minutes for information purposes was made by Rev. T.T. Shellman, seconded by Rev. Larrie Lovett, and carried unanimously.

REFLECTIONS & PROPOSALS

MODERATOR PHILPART

Moderator Philpart reported the Moderator's Reflections and Proposals for the 118th Annual Session:

Special Guest: Dr. Uzell Williams, CPA

Dr. Williams will be given oversight in record keeping. He will also help with making better use of foundation and not-for-profit statuses.

Special Guests: Pastor Wayne Lomax & Dr. Rosalind Osgood

Dr. Osgood and Pastor Lomax discussed how to become a better board and maximizing board potential. The gave starting strategies for improvement in May. These included:

- 1. Monetary contributions and in-kind donations from outside sources
- 2. Make the budget committee a standing committee
- 3. Make the election committee a standing committee
- 4. Committee members should be comprised of representatives from each auxiliary:
 - 1. Northern Fellowship
 - 2. Southern Fellowship
 - 3. Congress of Christian Education
 - 4. Laymen/Men & Women's Auxiliary
 - 5. Youth and Young Adult Auxiliary
- 5. Create a guidebook that will assist board/ministries to provide with guidelines that are rich and good for our past and future.
- 6. The vision of the moderator goes beyond church alone. The board must reflect, embrace and activate that vision.

IMMEDIATE PAST MODERATOR JOHNNY BARBER

Immediate Past Moderator Johnny Barber reported the status of vacant churches within the Association.

- 1. Mount Calvary of Pompano called Rev. Brandon Jones as pastor.

- 3. Friendship of Fort Pierce remains vacant.

Immediate Past Moderator Barber yielded to the Presidents of the Northern and Southern Fellowships to supplement his report.

- 1. President Barr, Northern Fellowship:
 - a. St. Matthew's of Wabasa: Due COVID, the Pastoral Search Committee has paused all activity until further notice.

- b. Mount Calvary of Pompano: Closing on final candidates.
- 2. President Ramsey, Southern Fellowship:
 - a. First Baptist Church of Bunche Park: Vacant

COVENANT PARTNER UPDATES

REV. DEMETRIC FORD & DR. VENITA TIMPSON

Covenant Partnership Updates were rendered. As of Friday, 05 February, there were one hundred twenty-one (121) total Covenant Partnerships and three (3)Corporate Covenant Partners. To wit: Faithlife Corporation, Nova Southeastern University, and First Prestige Insurance.

From 01 January – 05 February, \$6924.76 in Covenant Partnership funds have been renewed or added.

SCHOLARSHIP COMMITTEE UPDATES

SIS. ANGELIA SHELLMAN

Sister Angelia Shellman rendered the Scholarship Committee Update.

- 1. Cameron Mills, of Saint Paul of Delray Beach is the only scholarship applicant to date.
- The Leroy and Alberta Brant Scholarship was established by Sis. Valerie Brant Wilson. This is a \$1000 scholarship preferentially offered to applicants attending Florida Memorial University. If there are no eligible FECBA students, FMU will bless students in need.
- 3. Moderator Philpart and FECBA will match funds, making the scholarship \$2000 total.
- 4. 2021 applicants will be ready in mid-April; returning to original distribution in April.
- 5. Deadline for the scholarship is 21 August 2021.
- 6. Youth leaders can make application.
- 7. On 15 February, an education emphasis hour will be held in conjunction with Pastor Parrott, the messenger of the hour.
- 8. Covenant Partnership funds funnel into the scholarship.
 - a. Moderator Philpart noted that we have an educational foundation. Therefore, Pastors Lomax, Barber, and Osgood should be consulted in how to make better use of that foundation.

CONSTITUTION & BYLAW COMMITTEE

Rev. Larrie M. Lovett, II reported on updates from the Constitution and By-Law Committee. The original task of the committee was to prepare six amendments to the Constitution for FECBA approval—FECBA has this authority granted in Article XV of the Constitution—"This constitution may be altered or amended at any ("annual" is deleted) session by a majority vote, providing notice has been given in the previous session." As such, the authority to amend the Constitution and By-Laws is given in Article XV.

The document is an altered document, not an amended document. When a constitution is amended, it is done outside of the existing document, and is added and indicated by a numerical, or alphanumerical designation.

The existing constitution is a structural and informative document. When we deal with how we will govern ourselves, that's a separate document called the Bylaws. The Constitution and Bylaws are separate documents, as indicated on the NBC, USA, Inc. website, www.nationalbaptist.com

FOR THE GOOD OF THE ORDER: EXECUTIVE CABINET REPORTS

Reports were given by the Moderator's Executive Officers:

Women's Auxiliary: President Gloria Jackson-Davis

President Jackson-Davis noted that the Women's Auxiliary is prepared for the 118th Annual Session.

Men/Laymen's Auxiliary: President Raymond Smith, Sr.

President Smith indicated that the Laymen's Auxiliary is excited to meet with pastors, laymen and deacons. Dr. Harold Simmons, NBC Laymen's President Emeritus is the national guest at 9:30 am. The First Annual Address by Deacon Smith will be given. The goal of the auxiliary is to increase the participation of men and boys throughout the association, growing to three hundred (300) registered men this year, and to participate with a financial gift in Covenant Partners.

Congress of Christian Education: President Benjamin H. Parrott, Sr.

President Parrott reported that the Congress of Christian Education is planning for a virtual Congress again this year, due to the persistent preponderance of COVID-19 in South Florida. President Parrott is planning for morning and afternoon programming, and increased class offerings.

President Scott offered commentary on the role of women in FECBA.

Northern Fellowship & Women: Presidents Howard B. Barr, Jr. and Malinda Collins

Northern Fellowship are covenant partners. And, they referred the body to their report
emailed to the General Secretary. It follows:
