Invocation was given by Chairman Bryant.

Chairman Jimmie L. Bryant called the FECBA Board Meeting to order at 4:03 pm. Moderator Philpart asked to table the sharing of minutes from the previous Board Meeting until the October 2021 Joint Session, as General Secretary Paris was unable to join the proceedings until later. Chairman Bryant called for the Reading of the Agenda and its Adoption. *Congress President Benjamin Parrott moved to adopt the agenda. President Howard Barr, Jr. seconded the motion. The motion passed unanimously.*

REFLECTIONS & PROPOSALS

MODERATOR PHILPART

Chairman Bryant called for Moderator Philpart to begin with his reflections. Chairman Bryant reminded the board that Rev. S. S. Read should be listed as a Board Member Emeritus, and not simply removed from the Board. Discussion ensued:

Rev. T. T. Shellman noted that Rev. Maurice Alexander had been omitted from the list of persons to be added to the Board of Directors. Moderator Philpart affirmed the omission and called for its correction in the official minutes.

President Howard Barr, Jr. noted that Rev. S. S. Read should be recorded as Board Member Emeritus immediately, given his history and service to the Board. Moderator Philpart and Board Chair Bryant called for the correction in the official minutes.

The motion to accept the names for removal and addition to the Board of Directors, as well as the notation that Rev. S. S. Read will officially be named as a Board Member Emeritus, was made by Rev. T. T. Shellman. President Howard Barr seconded the motion. The motion passed unanimously.

Moderator Philpart then called for the Constitution Committee to update the Board on its developments.

CONSTITUTION & BYLAW COMMITTEE: Notifications & Updates *REV. LARRIE M. LOVETT. II*

Rev. Larrie M. Lovett, II reported on updates from the Constitution and Bylaw Committee. Rev. Lovett listed four items that were presently before the Constitution and Bylaw Committee. These were:

- 1. Clarifying the "Minister's Board" from the "Benefit Board"
- 2. Ensuring that the Bylaws provide instructions on internal audits, with specific regard to changes in the treasurer position.

- 3. Definitively stating that audits are conducted independently from the Finance Committee.
- Amending the Constitution and Bylaws to allow the Moderator to become the only elected officer in the Association. All other officers will be appointed by the Moderator.

In conclusion of his report, Pastor Lovett requested, to be ready for the October Joint Session, a working Board Meeting in Mid-September, and an Executive Board Meeting in Early October.

Chairman Bryant suggested the board revisit and assess the request for subsequent meetings as the Constitutional Committee's work progressed.
